

**Grand Saline City Council
December 19, 2023
Regular Meeting Minutes
6:00 P.M.**

A regular meeting of the Grand Saline City Council was called to order at 6:00 p.m. by Mayor Ridge Tardy. The Mayor announced a quorum present with the following: Councilmember Kathy Smith, Councilmember Aaron Miller, Councilmember Brandi Morris and Councilmember Leah Lamb present. Councilmember July Cato was absent.
